Ms. Harris called the Regular Meeting to order at 7:00 p.m. with the recitation of the pledge of allegiance led by Mr. Doss.

# Approval Consent Agenda

Dr. Mervilde recommended that the Board approve the Consent Agenda including the following items:

- Approval of the Minutes of the March 10, 2010 Regular Meeting
- Approval of Claims in the amount of \$3,150,093.90
- Approval of the Human Resources Report containing: Certified Personnel Two Resignations (9), (10); Classified Personnel Two New Appointments (125), (126).
- Approval or Acceptance of Non-competitive Grants, Gifts and Donations: There were no non-competitive grants or donations presented for the Board's approval.

# Mr. Kite moved approval of the Consent Agenda as presented. Mrs. Spann Roddy seconded. The motion passed 4-0.

#### Superintendent's Announcements

Congratulations to Coach Doug Mitchell and the North Central High School Boys Basketball team. They defeated Jeffersonville and will go on to play Warsaw in the State Finals at Conseco Fieldhouse.

This will be the last School Board Meeting until April 14<sup>th</sup>. School Board and Administrator school visits are scheduled for Thursday, March 25<sup>th</sup> to Westlane, Tuesday April 6<sup>th</sup> to Allisonville and Tuesday, April 13<sup>th</sup> to Spring Mill.

The District has surplus Title I money and will now be able to have summer school for about 400 Title I students.

Dr. Mervilde received detailed financial information today related to the new state law allowing a one-time transfer of money between funds to help schools with the Governor's recent reduction in funding. As discussed at the March 10<sup>th</sup> Board meeting, Dr. Mervilde emphasized

that this new law in no way changes the need to renew the District's funding referendum on May 4<sup>th</sup>.

Washington Township Schools will be closed next week (March 29 - April 2) for Spring Break. Board notes will not be published on April  $2^{nd}$ .

#### **Action Items**

1. Adoption of 2010-2011 and 2011-2012 School Year Calendars – Mr. Doss

#### **Information Items**

1. Progress Update on International Baccalaureate – Ms. Smith

Ms. Smith shared a progress update with the Board via Power Point. She talked about the International Baccalaureate authorization process a district has to go through. The total duration of the authorization process is usually two to three years. Teachers and Administrators have participated in two official Level One on-site International Baccalaureate trainings. The third Level One training will be held in May. Funding for International Baccalaureate will come from stimulus money, grants, private donations and partnerships. The Board had questions.
