

Dear MSD Washington Township Employee,

LAST CHANCE TO ENROLL AT DISCOUNTED RATES OFFER EXPIRES MARCH 31, 2012

- The online join site is available now. You will need to go to the link that is provided at the bottom of the marketing flyer (JOIN LIFE TIME ONLINE HERE) and register. The site requires that you register a credit card, debit card, checking OR savings account, even if you are only registering yourself. There **MUST** be an account in Life Time's system in order to process a membership and obtain a Member #. Please note that **NO** employee's personal account will be drafted for their portion* of the membership monthly, but will be drafted for add-ons to the membership (*please see MSDWT explanation of payroll deduction). In other words, if an employee would like to add-on add'l family members to their membership, the remaining amount that your payroll deduction does not cover will be automatically drafted from the employee's account on file (*Ex – since an employee's membership is \$19.99/mo and they want to add their spouse, which is an add'l \$19.99/mo, MSDWT will be invoiced or drafted ONLY the amount due for the employee, which is \$19.99; therefore the remaining \$19.99 will be drafted from the employee's account on file*). Employees can pay in advance for add-ons by cash or credit/debit card so the amount is not auto-drafted.
- The cost per eligible add-on to an employee's membership (see restrictions above) is the same rate as the employee rate. You are only charged for up to two adult add-ons to your membership, so if you have three or more add-ons, there would be no charge for the 3rd, 4th, 5th, etc., so long as these individuals are eligible add-ons. In addition, each Junior Member (under age 12) added to a membership is an add'l \$6.00 per month, which includes child care for up to 2 hours per day, swimming (if applicable) and rock climbing (if applicable). Some clubs do not have swimming or rock climbing.
- The corporate membership rate of \$19.99 per month that we've provided for you includes access to only the acquired Lifestyle locations, **unless** one of the upgrade options are otherwise selected on the online join site. To upgrade and have access to an existing Life Time facility, Castleton - Indianapolis, you must select the option below that best fits your needs. The following options will be on the online join site (see rate structure below):

Bronze Single Elite - \$19.99/mo (standard)
Bronze Couple Elite - \$39.98/mo
Bronze Family Elite - \$59.97/mo
*access to ONLY acquired LFF clubs in area
Gold Single Club Only - \$29.99/mo
Gold Couple Club Only - \$59.98/mo
Gold Family Club Only - \$89.97/mo
*access to ONLY <u>one</u> Life Time club (upgrade option available on join site) -no acquired LFF club access allowed
Gold Single Elite - \$35.99/mo
Gold Couple Elite - \$71.98/mo
Gold Family Elite - \$107.97/mo

*access to ALL LFF & Life Time clubs in area

***Kids ages 3mos–12yrs-old are an addt'l \$6.00/mo added to all membership types**

- Every employee who enrolls through the online join site will need select a home club, select a membership option, put in personal information for all individuals on the membership, provide a method of payment, provide a valid email address, and also register for myLT.com, (username/password is required). myLT.com is Life Time's member-only website, and it gives members access to explore areas of interest or passion, join groups or clubs within Life Time, check Group Fitness schedules daily, find Kids activities/programs, modify or change Personal Account information, access the Member Advantage program (which provides discounts to local partners of Life Time), and much, much more. You can also provide us feedback on how we're doing, add friends, and join in on discussions and forums. There's also a MYLIFETIME app available on Facebook for quick and easy access to Group Fitness schedules and other activities and events happening in your club. Furthermore, I've provided an attachment of a Sample Join Site for you to get an idea of how you will register (please note that the rates you will see do not apply to your corporate program).

NEW RATES EFFECTIVE MARCH 31, 2012

As you know, the initial membership offering that was provided for MSDWT employees was heavily discounted from the standard Life Time club rates.

We have been informed by LIFETIME that on **April 1st, 2012**, these discounted rates will no longer be available for new enrollees. The new rates will be the **Standard Life Time membership rate** which means there will no longer be a savings for employees that are not signed up prior to April 1, 2012. It is

important to know that this change does not affect currently enrolled employees or employees that enroll on or before March 31st, 2012; therefore, the discounted offer is available until then.

Up to this point, most employees that have wanted to take advantage of this opportunity have most likely done so, but the same opportunity still exists for those that have been thinking about getting involved.

Since the savings MSDWT employees enjoy will no longer be available for employees that are not enrolled before April 1, 2012, MSDWT will close enrollment as of March 31, 2012. MSDWT will continue the payroll deduction for those employees currently enrolled and for those that enroll on or before March 31, 2012.

From Joe Licata, CBO, MSDWT - PAYROLL DEDUCTION PROCEDURE

When the payroll department has been notified by Life Time that you have enrolled as a member, a \$10.00 per pay deduction will begin with the pay immediately following the notification. We will deduct \$10.00 twice each month so we can pay Life Time for a \$19.99/month membership.

If you opt for a membership that costs more than \$19.99/month, the excess monthly cost will be charged to your credit card on file with Life Time. The district will only pay \$19.99 per month to Life Time for you. If your work schedule is less than 12 months, or 26 pays, the difference between what has been withheld and \$19.99 will also be charged to your credit card. For example, if you don't work in the summer, the full \$19.99 would be charged to your credit card since you may not have a pay check to withhold from. When you come back to work in August, the deduction will start again with our first pay of the new school year.

If you wish to **terminate your membership**, notify the payroll office in writing (e-mail is OK), and the deduction will be stopped. You must also follow Life Time's cancellation policy or your credit card may continue to be charged.

Life Time Fitness Corporate Member Cancellation Policy

Updated February 22nd, 2012

Please read below for important information regarding the Cancellation Policy with Life Time:

If an employee (member) wishes to discontinue their corporate membership, it is up to that individual to personally cancel via one of the following methods (in addition to notifying your Payroll Office):

- **In person at a Life Time facility**
- **Certified Mail to Life Time**

Furthermore, the employee would still be responsible for the following month's dues from their own personal account (*Example – if an employee provides, in writing, their cancellation notice at a Life Time facility [or via Certified Mail] on any day of any given month, that employee would be responsible for paying all of the following month's dues as well*). **Cancellation is effective the last day of the month following the month of notification.**
