- Maintenance and facility improvements are reactive rather than preventative
- Increasing need for complete renovations at all buildings
- Safety and security enhancements needed
- Decline in meeting instructional needs
- Enrollment projections
- Aligning community and district desires

Future Challenges

- Increased number of students per classroom
