Should a successful Bidder withdraw his Bid, or fail to execute a satisfactory Contract by providing Payment and Performance Bonds, Certificate(s) of Insurance, subcontractor and Materials listing and any other required documents within the required time periods after notice of acceptance of this Bid, Hagerman/Powers/Corgroup may declare the Bid as non-responsive and declare the Bid Security forfeited as liquidated damages, not a penalty.
